# **FINANCIAL MATTERS**

The Treasurer's Report presented at this year's AGM included the paragraph "there are a few grey clouds on the horizon we need to be aware of and bear in mind. As we all know the cost of living is taking a toll on all costs, but the cost of insurance is a key concern. In 2023 the insurance premium increased 16% from the previous year. Given the national insurance cost of weather events of 2023, insurance premiums are now rising steeply, as I am sure many of you will have witnessed yourself with your own home and contents policies. In addition, we are also reviewing the value of our cover, given the substantial increase in building costs over the last few years. Therefore, we are anticipating further significant increases in insurance costs."

Since the AGM, we received the valuation report from a local Registered Valuer, and it indeed showed we were significantly underinsured for the replacement cost of the building and improvements. The impact of this increased sum insured on the premiums we must pay has been dramatic, rising by \$4,700 in the current insurance year (which ends on 31st May). This

is likely to increase further again in the new insurance year. Our insurance broker is currently seeking alternative quotes from other insurers but is not hopeful of an improved outcome.

As protecting our main asset, the Club building, is a key responsibility of the Committee we are regrettably needing to raise additional funding to cover this increase in expenditure. As a direct consequence, we advise that the price of a session ticket increases in price by \$10 to \$60. This new cost equates to \$5 per session of play. Please also note that the cost of a casual session of bridge is increasing to \$7(from \$5).

These pricing changes are effective immediately.

# Waikanae Open Tournament 2025

The Wellington Region Bridge Committee (WRBC) recommended the Waikanae Club also formally write to Allan Morris, the Chair of NZ Bridge, over the clash of our Open Tournament and the NZ Bridge on-line tournament the same weekend. This has been done. To date, there has been no response from Allan (NZ Bridge).

#### The Waikanae Bridge Club e-mail Address

In view of the Spark NZ decision to introduce a charge for the continued use of 'xtra' e-mail addresses from mid-May 2024, it was agreed that the Club would discontinue the xtrra e-mail address from 16 August 2024. A 'gmail' address will be introduced as soon as possible.

#### **Waikanae Clubroom Rental**

The Committee agreed to offer the Paraparaumu Country Music Club rental of the Clubrooms on a year's trial. The rental includes allowing installation of a storage cupboard. The Music Club will be notified of the pending GST increase.

#### **Club Social Events**

The Committee agreed that it was no longer viable to provide free social events. It was further agreed that all events will now be charged and will be financially self-sustaining.

#### **Subscriptions for New Members**

The Committee agreed that members who join after 30 June will be charged Full-member - \$50, Secondary member - \$35.

### Life Membership

The Committee agreed that criteria for Life Membership is to be established. A first draft of a proposal has been circulated for Committee members input/comments and the updated criteria will be presented to the May meeting as a start point. The new Constitution is to be more precise about the process. There will be an associate by-law in support of the constitution.

It was agreed that a US \$100 voucher and card be purchased by Maureen Pratchett to recognise the ongoing support from B Fearn.
